- Q4. **Either A.** Just as regional cooperation is necessary for African integration, national integration is necessary for regional cooperation. Discuss. (15

marks)

Q5. **Either A**. In the discussion between Ibrahim Mo and Aliko Dangote, Dangote laments having a cement factory 28 kilometres to the Benin border, a country where he cannot export the cement. He also laments spending weeks to Togo, a mere hours' journey.In similar discussions, it is revealed that it is cheaper to export a car from Japan than transporting one from a neighbouring country to another in Africa.

Critically assess this situation, i.e. where is the problem and what can be done about it. (15marks)

- Or B. According to the National News, p. 10 of the Friday May, 2019, Daily Nation, 'Coast leaders say that ferrying cargo from Mombasa to Nairobi via SGR trains has killed the once vibrant regional economy'. Using your knowledge of the EAC institutional and legal framework, discuss the coast leaders' concern. (15 marks)
- Or C. Having seen Aliko Dangote's Oil Refinery Factory, for example, discuss the hullabaloo about 'added value': either i.Africa sticks to its 'original' role of supplying raw materials to the industrialised world, or ii. The continent graduates to the level of processing its raw materials and exporting industrial products. (15 marks)
